OUR ACCOMPLISHMENTS FOR HEMP:

- » Helped secure federal legalization through the 2018 Farm Bill
- » Led successful lobbying campaigns in more than two dozen states to provide explicit legal protection for hemp and hemp products
- » Working closely with Congress to develop a legal regulatory path for hemp-derived CBD
- » Secured federal legislation to provide flexibility for hemp farmers under USDA regulations
- » Advocated for successfully passed Emergency Relief for Farmers of Color Act

THE WORK AHEAD OF US:

- » Legalize hemp & CBD products in all 50 states
- » Finalize FDA's pathway for the retail sale of CBD through passage of HR 841
- » Help ensure access for hemp farmers and CBD companies to banking and merchant services
- » Work with USDA to protect in-process hemp extract that temporarily exceeds .3% THC
- » Further our mission to promote justice and equity in the hemp industry
