## **DRACONIAN THC LIMITS ON HEMP PRODUCTS IN CALIFORNIA COULD COLLAPSE MARKET**

*An Amendment Filed By The California Department of Public Health Would Eliminate  
The State's Broad Spectrum And Full Spectrum Hemp And CBD Extract Market*

Washington D.C. — Today, the U.S. Hemp Roundtable sent out an urgent action alert calling on hemp stakeholders, consumers and advocates to help stop a concerted effort to eliminate the state's broad spectrum and full spectrum hemp and CBD extract market. [Click here](#) to read the alert.

[AB 420](#) has been introduced by longtime hemp champion State Assemblywoman Cecilia Aguiar-Curry as an effort to clean up provisions in the current hemp law and crack down on bad actors in the space. Unfortunately, marijuana monopolists in the state are trying to use this vehicle to impose draconian THC limits on hemp and CBD products which would eliminate the broad and full spectrum hemp marketplace.

Now, the California Department of Public Health just joined the fray, offering a [poison pill amendment](#) that would set the limit for total THC in hemp at an infinitesimal 0.001 mg/g.

"The proposed 0.001 mg/g total THC limitation on hemp products in California would severely cripple, if not completely collapse, the state's hemp-derived cannabinoid market while having a devastating impact on the industry nationwide," said **U.S. Hemp Roundtable General Counsel, Jonathan Miller**. "We hope Hemp Supporters will act now to help protect broad spectrum and full spectrum hemp products."
